

**SONNING CRICKET CLUB**  
**PRIVACY NOTICE FOR OUR JUNIOR MEMBERS**



We at Sonning Cricket Club want to make sure all the personal details we hold about you are safe and secure, so we have put together this note to tell all of our junior members how we make sure we just do that and what to do in case you have any questions for us or want to see what information we have. We are, what is known as, **a data controller**. This means we have control over how your details are used and who we pass them to.

Sometime organisations like ours need to appoint an individual called a “**Data Protection Officer**” to make sure that we are being very careful with your information. We don’t need to have Data Protection Officer, but we have decided to put together a team of people instead to make sure your details are safe. **1. WHAT TYPE OF DETAILS DO WE COLLECT FROM YOU?**

We might collect the following **personal details** about you during before, during or after your time as a member, such as:

- your name
- your address;
- your birthday;
- your gender;
- your school;
- membership details including when you signed up to be a member;
- all records of when you or your parents/guardians contacted us, or we contacted them by email or when you asked us to do something;
- records that tell us when you were at our events or competitions;
- videos and photos of you;
- records of whether you play at a county/national level;
- details of family members and other people we might need to contact in case of an emergency;
- records of what games you have attended and how well you are performing in those games or on any development programme you are registered to; and
- any disciplinary information or details of any issues you have us or we have with you; and

**2. SPECIAL CATEGORIES OF PERSONAL INFORMATION**

We may also hold and use what is called “**special information**” such as details about your health including ongoing medical conditions as well as any injuries you have/have had or times you may not have been very well. In the table below, where we use this **special information** you will see this symbol ● and we will only use it if we have a really good reason to do so such as:

- if it is in the interests of the public and we have a lawful reason to use it;
- we need it to help us with a legal case we are involved in;
- certain laws allow us to use it; or
- you have told us you are happy for us to use it.

In the table below, we refer to these as the “**special reasons**”.

**3. WHERE DO WE GET THIS INFORMATION FROM?**





We will normally collect personal information about you when your parents/guardian create an account for you on our site at <http://members.sonningcc.com> to become a member of Sonning and Charvil Junior Cricket

Club or via the Teamer website/app that we use to organise our matches, or during matches via the scoresheets that our scorers maintain.

Your parents/guardians will also provide us details of family members and emergency contacts when they register you. These family members and emergency contact also have a right to know and to be aware of what personal information we hold about them, how we collect it and how we use and may share that information. Please share this privacy notice with them. They also have the same rights as set out in the “**Your rights in relation to personal information**” section below.

#### 4. HOW DO WE USE YOUR INFORMATION?

What do we use your information for?	What type of information do we use?	What reason do we have to use it (this is the boring legal bit...)
<b>To make sure your membership with us runs smoothly and we can provide the very best service for you.</b>	All contact and membership details.	We need all this information to make sure we do a good job in managing your membership with us.
<b>To send your parents/guardians information which we think you might like based on the type of membership account you have with us such as details about competitions and events we are running, offers and discounts which our shirt suppliers may have, details of cricket clubs run by any of our coaches in the school holidays and any updates on cricket.</b>	All contact and membership details.	We need all this information to make sure we do a good job in managing your membership with us.
<b>To help you if you have a question or you are not happy with something we have done.</b>	Contact details and any chats we have had.	It is in our interests to make sure we deal with any issues you have quickly.
<b>We will keep all of your details on our files.</b>	All of your personal details. ●	It is in our interests to hold your details on file so we can deal with any issues with your membership and to make sure we do a good job in managing your membership. Sometimes we may have to keep your details because the law tells us we have to.  If we use any ‘ <b>special information</b> ’, we will only do so on the basis of one of the ‘ <b>special reasons</b> ’ we talked about above.
<b>To promote the sport, our events and membership packages.</b>	Any photos or videos of you.	Only where you or your parents/guardians have told us you are happy to use our photos/videos.

In some cases we might need the information you have given us to make sure we can do what we say we are going to do with your details. Other times, we may not need it, but if we don't have it, we may not be able to provide you with the best possible service.

## 5. DO WE MARKET TO YOU?

We will only contact your parents/guardians in order to tell you about games, training or end of season awards. We will not send you emails about other products and services as we do not provide any.

## 6. WHO ELSE MAY USE YOUR DETAILS?

We may send your details to others to help us run our organisation. These are:

- **Anyone you have said you are happy for us to send your details to.**
- **To any regional or governing body:** to help us to improve and keep an eye on developments in the sport.
- **The Government or our regulators:** where the law tells us to do so or to help them with any investigations.
- **Police, law enforcement and security services:** to help them with any investigation, prevention of crime or matter of national security.

## 7. ARE YOUR DETAILS SAFE?

We have put in place security measures to make sure your details don't go missing or get used in a way they shouldn't be. We have a great team of people working with us who know how to use your details securely and will only use your details when and how we tell them to.

***Did you know that all 'data controllers' based in the European Union and the UK like us are subject to laws that make sure that your personal details are safe?***

## 8. HOW LONG DO WE KEEP PERSONAL INFORMATION FOR?

We collect personal details from you for different reasons and so we might keep it for different lengths of time. For example, we might have to keep it for a long time for legal reasons, but most of the time, we will keep your details for 6 years after you last get in touch with us.

It is important to make sure that the details we hold about you is accurate and up-to-date, so make sure you let us know if anything like your email address or phone number changes. You can normally do this through our membership portal or by contacting us at [scjcricket@gmail.com](mailto:scjcricket@gmail.com).

## 9. WHAT ARE YOUR RIGHTS?

***Did you know you can ask us to do lots of things with your details?***

You can ask us:

- to tell you how your details are being used;
- to provide you with a copy of all details we hold on you;
- to correct some of the details we hold if they are not correct or out of date like your contact details for example;
- to delete all of the details we hold on you (unless we have a good reason not to!);
- to stop using your details in a certain way;
- to send your details to you or another organisation like any club you play at for example; and

Some of the rights may not always apply to the personal details we hold for you as there are sometimes requirements and exemptions attached which means we need to hold on to certain information and other times the rights may not apply at all.

**DON'T FORGET** though, if you have told us we can use your information in a certain way and you would like us to stop, you can tell us to stop at any time and you can always tell us to stop sending you marketing messages. 10. **WHAT HAPPENS IF WE NEED TO CHANGE THIS NOTICE?**

Keep an eye out for changes to this notice online. If we make big changes the version date at the bottom of the notice will be updated. Of course, where we are required to do so by law, we will ask for your permission before we change the reason for using your details.
